Academic Practice Partnerships for a Hawaii State BSN Summer internship in Community Based Primary Care for Underserved Populations.

With a two year HRSA funded grant, Chaminade University of Honolulu, School of Nursing is in the process of partnering with the 14 federally funded community health centers on five Hawai'ian Islands to provide a summer internship for as many as 42 senior BSN students so they can develop primary care competencies necessary for a primary care role. To address challenges in recruiting RNs to primary care in isolated regions, we are working to create workforce opportunities in the communities where the students often already live. This workforce project will provide Hawaiian communities with a

significant leadership role for new BSNs. Indicators of success are measured using quantitative data: 1. students' scores on knowledge of social determinants of health, 2. desire to work in a primary care setting, 3. increased scores on senior level nursing course exams, 4. job applications and hires once the new graduates are ready for RN employment. This program was created out of an academic service partnership aimed at improving clinical nursing education for students, new graduate nurses and RN preceptors and clinical nurses who transitioned in teaching roles in the service setting.
